CONDITIONS OF CARRIAGE

1. Said to Contain Basis: All the consignment shall be booked on "said to contain basis", i.e. SMCs shall be under no obligation to verify the description and contents of the shipment declared by the Consignor on the dockets/invoices and as such the consignee shall undertake and ensure to make correct and accurate declaration on the dockets/invoice bill. However, SMCs reserve the right to inspect and/or re-weigh the contents of shipment not conforming to these terms and condition only after duly informing consignor regarding the reasons for such inspection and/or refusal and after receiving the confirmation from consignor. Consignor shall not make handover any shipment consisting of prohibited, restricted or dangerous articles, and SMCs shall not be liable against all claims, losses, damages and expenses incurred by SMCs due to any damage, restriction or dangerous items entering in the network of the SMCs due to any commission or omission of Consignor.
2. Prohibited Items: The currency, bank cheques, bank bills, bearer bills and/or similar other documents, Gold, Silver, Jewellery, Precious stones, Liquid, Semi Liquid and inflammable goods, narcotics and/or any item which are prohibited and/or restricted by statutory law and rules are strictly not accepted by us. If such articles are enclosed without our information, the Company's franchise will not be liable for the same and we shall stand as evidenced by such a ticket.
3. Limitation of Liability: (a) In case of loss, theft, damage and mis-stuffing of booked consignment, maximum liability of the Company's Franchise shall not be exceeding to the sum equivalent to 10 times of weight charges for documents and 5 times of freight charges for parcels (below Rs. 5000/-) or the value of the consignment mentioned on the docket whichever is less. (b) All the high value shipment (above Rs. 5000/-) and Fragile Shipment should be insured by the Consignor while booking. If any such shipment booked/consigned in such cases, in the event of loss/damage or theft of such shipment the Company's Franchise will not be liable to reimburse to the customer.
4. No Service Area: Where the DOX or Non-DOX booked exclusively for the area which carries under NCA No. Service Area) i.e. beyond the network of SMCs/SP, in such event the said shipment shall be consigned by the party/consignor. In case of NCA service the Maximum Liability of the Company's Franchise shall be limited up to return of the right amount only.
